ASEAN SAI is designed to be a forum to promote and enhance capacity and technical cooperation among SAIs of ASEAN member states, to promote exchange of knowledge, best practices and lesson learnt, and also to support ASEAN in promoting good governance. ASEAN SAI will also provide the possibility to be the external auditor of ASEAN in the future in order to support good governance in ASEAN.
