Annex. REVIEW ON WORK PLAN 2016 – 2017

During the period 2016 – 2017, Strategic Plan Committee (SPC) mostly well fulfilled its responsibilities and mandates as stated in its ToR and followed the set WP. Key activities carried out involves regular tasks in terms of monitoring and evaluating the implementation of ASEANSAI SP 2014 – 2017, developing Annual Results Report and other reports as stipulated in ASEANSAI Rules and Procedures, continual supporting the application of Monitoring and Evaluation system by raising SAI's awareness on the value of the system, reminding their usage of tools and completion of Committees' Progress Report. In 2017, SPC focused on developing the ASEANSAI Strategic Plan 2018-2021, which was kicked off by the 7th SPC meeting in Hanoi, Vietnam in August 2016. Basing on the agreed Action Plan, SPC in coordination with other Committees have finalized the draft SP 2018-2021and Work Plan 2018-2019 to be submitted to SOM in Cambodia in August 2017.

Though the M&E system was not really comprehensively applied by member SAI in all ASEANSAI events and activities, SPC made a great efforts as a whole in taking the system into practice for the implementation of the SP. Therefore, it will continue be the strategic objective to be contributed and achieved by SPC in the coming period.
