public accountability in the use and management of public funds. He also paid particular attention to the development of the AGO's capacity in carrying out its duties effectively.



Putrajaya, Malaysia's first Intelligent Garden City, is the futuristic and trendy administrative centre of the Federal Government. Here we see a convergence of the past, present and future. A union of heritage, design and technology.

Putrajaya is a planned city, located 25 km south of Kuala Lumpur that serves as the federal administrative centre of Malaysia. The seat of government was shifted in 1999 from Kuala Lumpur to Putrajaya and in 2001, Putrajaya became Malaysia's third Federal Territory after Kuala Lumpur and Labuan.

The city is named after the first Malaysian Prime Minister, Tunku Abdul Rahman Putra. "Putra" also means prince in Bahasa Melayu while "Jaya" means excellent or success.

Putrajaya was conceptualized on man's three core relationships the spiritual relationship between man and his Creater, the social inter-action between man and man, and environmental harmony between man and nature. Putrajaya has many objectives: to be a vital development catalyst; to act as model city; and to be nerve centre of the nation.

Tun Dr Mahathir Mohmad, best known for his Vision 2020 and former Prime Minister, unveiled Putrajaya on June 4, 1999, as a shining example of his grand vision for the future. Putrajaya has since come to symbolize the branding of Malaysia.

Putrajaya's core areas are grouped into identifiable precincts, each distinctly landscaped and sculptured. Futuristically-designed facilities juxtapose with centuries-old Islamic architectural designs. They make for an awe-inspiring sight. Boulevards add colour, depth, space and character to an already inspired environment.

It s a socially healthy environment. Self-contained, and very much in touch with the needs of 21st Century living, Putrajaya mirrors good governance on the part of the Government. It reflects a political leadership that promotes good citizenship through informed participation, compassion and fairness. Citizen participation, of course, ensures greater transparency, greater accountability, and leads to public policies that better satisfy the people s needs.

Putrajaya has refined the definition of a planned city to one that combines the joys of the countryside with urban comforts. This city of commanding sights stands on land formerly occupied by rubber and palm oil plantations. It has been built from scratch into what some refer to as urban utopia.

Architecturally, Putrajaya can be described as an indigenous city with a modern look. And reflecting a well-planned city, the buildings here are as visually interesting as they come, reflecting various origins.

Putrajaya is a city ahead of its time.

Therefore, in March 26, 2012, The Chairman of ASEANSAI, Mr. Hadi Poernomo, sent the request to ASEAN Secretariat to propose ASEANSAI to be an Associated Entity with ASEAN and listed in Annex 2 of ASEANSAI Charter.

The Committee of Permanent Representative (CPR) to ASEAN on February 6, 2013 granted the approval of ASEANSAI to be an entity associated with ASEAN. This news was delivered by the Secretary General of ASEAN, Mr. Le Luong Minh, on his letter to the Chairman of ASEANSAI dated February 21, 2013.

With this approval, ASEANSAI is now an entity that is associated with ASEAN listed under the category of

"Other Stakeholders" in Annex 2 of ASEAN Charter, and also brings some responsibilites and obligations to ASEANSAI as stated in the ASEAN Guidelines on Accreditation of Civil Society Organizations (CSOs).

As entity associated with ASEAN and categorized as a civil society organisation (CSO), ASEANSAI is a non-profit organisation of ASEAN entities, natural or juridical, that promotes, strengthens and helps realise the aims and objectives of the ASEAN Community and its three Pillars – the ASEAN Political-Security Community, the ASEAN Economic Community and the ASEAN Socio-Cultural Community.

This status will strengthen the ASEANSAI commitment to continue the good cooperation with ASEAN for the achievement of ASEAN Community goals.







From 19th to 20th February 2013, the Asian Organisation of Supreme Audit Institutions (ASOSAI) held its 46th Governing Board Meeting in Manila, Philippines. The meeting brought together more than 50 delegates from thirteen Supreme Audit Institutions in their capacities as members of the ASOSAI Governing Board and Audit Committee as well as 5 observers from the INTOSAI Development Initiative and ASEAN Supreme Audit Institutions (ASEANSAI). ASEANSAI was represented by Pengiran Haji Abdul Rahman bin Pengiran Haji Mat Salleh, Auditor General of Brunei Darussalam as Vice Chairman of ASEANSAI.

The meeting began with an opening address from His Excellency Vinod Rai, Chairman of ASOSAI followed by a welcoming speech from the Chairperson of the Commission on Audit of the Republic of the Philippines as the host of the ASOSAI Governing Board meeting. This was followed by reports by ASOSAI Governing Board members and the invited observers.

During the proceedings of the 46th ASOSAI Governing Board Meeting on 19th February 2013, the Vice Chairman of ASEANSAI gave a speech on the activities of ASEANSAI. In his speech, the Vice Chairman highlighted the notable achievements accomplished by ASEANSAI since its establishment in November 2011 such as the formulation of the draft ASEANSAI 2014-2017 Strategic Plan by the Strategic Plan Committee; the development of a set of rules and procedures to enhance the governance and financial management of ASEANSAI by the Rules and Procedures Committee; the parallel seminars on Financial Management Accountability Index and Non-Revenue Water Audit and also the ASEANSAI Symposium on Good Governance organized by the Knowledge Sharing Committee; as well as the ASEANSAI Workshop on Quality Assurance in Financial Audit conducted by the Training Committee.

The Vice Chairman further added that all activities and operations of ASEANSAI was further facilitated by the support of the ASEANSAI Secretariat managed by SAI Indonesia whilst at the same time was also actively forging relationships with relevant stakeholders as well as pursuing potential cooperation with donor organisations and other international organisations.

The Vice Chairman clearly stated that the establishment of ASEANSAI was not to act as a standard setting body nor to create new guidelines but to enhance the capacity of its members in order to safeguard a stable ASEAN Community. Thus, it can be said that activities of ASEANSAI are closely aligned with INTOSAI and ASOSAI.

Last but not least, the Vice Chairman reiterated ASEANSAI's commitment to close cooperation with ASOSAI as both regional organisations which share a similar goal on promoting good governance can corroborate closely to enhance their members' capacities as supreme audit institutions.
