Forty six participants from 16 ASOSAI member SAIs and three participants from one EUROSAI member SAI attended the meeting with technical guidance provided by six Mentors and one Subject Matter Expert (SME) from SAIs of Bhutan, China, Indonesia, Pakistan and Philippines, and one Project Manager from IDI. A representative of the Capacity Development Administrator of ASOSAI (SAI Japan) also participated in the seminar for its management.

At the meeting, the audit plans that SAI teams submitted to IDI prior to the meeting were peer reviewed and reviewed by the Mentors and the SME, and based on the feedback they received, the SAI teams discussed the revision of their audit plans
