















MINUTES OF DONOR COORDINATION MEETING

5th November 2017

Landmark Mekong Riverside Hotel, Vientiane, Lao PDR

1. DATE AND VENUE

- 1.1 The 2017 ASEAN Supreme Audit Institutions (**ASEANSAI**) Donor Coordination Meeting was held on 5th November 2017.
- 1.2 The event took place in Diamond Room, Landmark Mekong Riverside Hotel, Vientiane, Lao PDR.

2. PARTICIPANTS OF THE 2017 ASEANSAI DONOR COORDINATION MEETING

- 2.1 The 2017 ASEANSAI Donor Coordination Meeting was attended by 44 delegates/representatives from:
 - i) Jabatan Audit Brunei Darussalam (SAI Brunei);
 - ii) National Audit Authority of Kingdom of Cambodia (SAI Cambodia);
 - iii) The Audit Board of the Republic of Indonesia (SAI Indonesia);
 - iv) The State Audit Organization of Lao P.D.R. (SAI Lao);
 - v) Jabatan Audit Negara Malaysia (SAI Malaysia);
 - vi) Office of the Auditor General of the Union, the Republic of the Union of Myanmar (SAI Myanmar);

 - viii) Auditor-General's Office of Singapore (SAI Singapore);
 - ix) Office of the Auditor General of Thailand (**SAI Thailand**);

3. OPENING SPEECH FROM THE PRESIDENT OF THE STATE AUDIT ORGANIZATION OF LAO PDR

- 3.1 Her Excellency Dr. Viengthong Siphandone, Vice Chairperson of ASEANSAI and President of the State Audit Organization of Lao PDR delivered her Opening Speech.
- 3.2 In her speech, Her Excellency Dr. Viengthong Siphandone:
 - conveyed her warm welcome to all representatives of ASEANSAI members and development partners such as ADB, British Embassy in Vientiane, European Union to Lao PDR, German Government, SAI Norway, SAI Sweden, and the World Bank in the 2017 ASEANSAI Donor Coordination Meeting.
 - explained that past successes of ASEANSAI in promoting competency development of auditors and in developing ISSAI auditing standards is one of the milestones in ASEANSAI's 6-year history.
 - ❖ as Vice Chairperson of ASEANSAI and the next term of ASEANSAI Chairperson, showed her interest to engaging with the ASEANSAI Secretariat to establish a platform to integrate the technical features required to meet the mutual targets on a stable and established basis.
 - Informed attendees that the main objective of the 2017 ASEANSAI Donor Coordination Meeting is to reflect on past relationship, to develop new relationship and to chart a way forward between ASEANSAI and development partners.

4. STATEMENT FROM CHAIRMAN OF THE AUDIT BOARD OF THE REPUBLIC OF INDONESIA

- 4.1 His Excellency Dr. Moermahadi Soerja Djanegara, Chairman of the Audit Board of the Republic of Indonesia delivered his statement.
- 4.2 In his speech, His Excellency Dr. Moermahadi Soerja Djanegara:
 - expressed his gratitude to all attendees for agreeing to join in with the 2017 ASEANSAI Donor Coordination Meeting.
 - pointed that a deeper strength and competency in public auditing is one of the needed matters, and ASEANSAI with the assistance of International partners, is moving forward with ISSAI best practice development and knowledge sharing. Therefore, all members of ASEANSAI recognize and appreciate the invaluable support of international partners.
 - explained that in escalating the role of ASEANSAI in regional and national levels, SAI Indonesia supports the implementation of ISSAI and other INTOSAI good practices, promote good performance of member SAIs, support member SAIs to fulfill their role towards the successful achievement of the Sustainable Development Goals, strengthen ASEANSAI's active role within ASEAN agenda and improve the cooperation with regional and international partners. Further, as the head of ASEANSAI Secretariat, Mr. Hendar Ristriawan will be hoping to formalize new long-term and flexible arrangements with each international partner within a Donor-Forum arrangement, giving benefits of an outlook-driven approach for shared capacity building objectives.
 - pointed that the 2017 ASEANSAI Donor Coordination Meeting is a platform for coordination among donors, implementers and SAIs to create synergy for donors and ensure the alignment of activities. Further, SAI Indonesia, in the capacity as ASEANSAI Secretariat, welcome the donor's support in helping to achieve effectiveness and efficiency, and to achieve sustainable stakeholder satisfaction while ASEANSAI pushes forward with its new strategic plan.

5.1 After the speeches, there were group photos for all delegates and guests.

6. PRESENTATION FROM EACH ASEANSAI COMMITTEE CHAIRS ON ITS PRIORITIZED PROJECTS

- 6.1 The Honorable Mr. Hendar Ristriawan presided the 2017 ASEANSAI Donor Coordination Meeting and opened the meeting by explaining the rules and proceeding of the meeting and information about the meeting agenda. Further, he invited all the donors to introduce themselves briefly.
 - 1) Representative from GIZ introduced its delegates and explained its focus of cooperation as the following:
 - a) The German government has been supporting ASEANSAI since 2013 and it will end in 2018.
 - b) GIZ works with ASEANSAI as the regional organization in organizational development, supporting the ASEANSAI through its committees and aligning its support with the strategic plan of ASEANSAI.
 - 2) Representative from World Bank introduced himself and expressed his heartfelt since he witnessed the establishment of ASEANSAI in 2011. The World Bank also witnessed the process of ASEANSAI sharing knowledge and capacity building. Currently, the World Bank has supported ASEANSAI in the area of ISSAI Implementation; this project shows good relationship and coordination among donors working together in ASEANSAI.
 - 3) Representative from Swedish National Audit Office (SNAO) introduce its delegates and informed that the involvement of SNAO in the ASEAN starting in 2013 jointly with the GIZ Project.
 - 4) Representative from ADB introduced its delegates and pointed out his involvement in the INTOSAI Donor Cooperation. He mentioned about the initiative of Global Call for Proposal from the INTOSAI where SAI can submit online proposal for its strategic plan and work plan to obtain funding.
 - He also extended a general invitation that ADB will host a programme from IPSAS Board in May 2018.
 - 5) Representative from SAI Norway introduced its delegates and informed that they have been involved with seven countries and one region (AFROSAI-e). He pointed out 4 focus areas: audit on extractive industries, IT Audit, Developing

- Audit Management System and Environmental Audit. SAI Norway also actively participates in the development of SAI Performance Measurement Framework (PMF). He emphasized the need for synergies between bilateral and regional support.
- 6) Representative from European Union (EU) introduced its delegate and pointed out that EU has been increasingly engaging with SAIs, particularly in the regional level. They aimed at strengthening the accountability system and in this occasion they saw the opportunity in engaging increasingly with ASEANSAI (1) region to region dialogue and (2) ASEANSAI can represent a very useful platform to support further trilateral cooperation in the region. The EU intends to leverage the differences among SAIs in the region and work together with ASEANSAI and SAI in the region to strengthen the SAI cooperation. They expressed its willingness to engage with the continuation of the donor coordination meeting.
- 6.2 INTOSAI Donor Secretariat sent a video recording which was presented during the meeting. They presented about the Global Call for Proposal (GCP):
 - a. INTOSAI Donor Cooperation is a strategic partnership between the International Organization of Supreme Audit Institutions (INTOSAI) and the Donor Community.
 - b. The GCP seeks to match SAI capacity development proposals with donor funding or INTOSAI support. In this way it empowers SAIs in developing countries to drive forward their capacity and performance by ensuring that their proposals are SAI-led and aligned with the individual SAI's strategic plans.
 - c. The support are provided by:
 - Development banks
 - Donor agencies
 - The SAI Capacity Development Fund
 - The INTOSAI Development Initiative
 - SAIs with their own development resources like Norway and Sweden
 - SAIs with in-kind support like India, Brazil and Mexico.
 - d. The GCP provide multiple benefits, and can open numerous doors for SAIs:
 - Providing a gateway to multiple donors and providers of support.
 - Rolling process and proposals can therefore be submitted at any time.
 This essentially means SAI can adapt its submission to the donor processes and programme cycles, increasing the chances of success.

 The programme provides stronger peer to peer to support, as well as assistance with concept note development, and also ensures improved coordination amongst providers of support.

6.2 Presentation of Strategic Planning Committee

- 6.2.1 The Honorable Mr. Hendar Ristriawan invited Ms. Do Thi Binh from SAI Vietnam as the representative of the Chair of ASEANSAI Strategic Planning Committee to present the prioritized projects of ASEANSAI Strategic Planning Committee.
- 6.2.2 In her presentation, Ms. Binh explained two prioritized projects of ASEANSAI Strategic Planning Committee, which are to coordinate with Committees Chairs on upgrading ASEANSAI's current Monitoring & Evaluation System (MES); and to support SPC in developing the ASEANSAI Strategic Plan 2022 2027. The presentation slide is as attached in **ANNEX 4**.

6.3 Presentation of Training Committee

- 6.3.1 The Honorable Mr. Hendar Ristriawan invited Ms. Luz L. Tolentino from SAI Philippines as the representative of the Chair of ASEANSAI Training Committee to present the prioritized projects of ASEANSAI Training Committee.
- 6.3.2 In her presentation, Ms. Tolentino proposed three prioritized projects from ASEANSAI Training Committee, which are ASEANSAI Follow-Up Workshop on the Audit of Public Procurement (FUWAPP); Workshop on the Audit on Preparedness of Countries for Implementation of Sustainable Development Goals (SDGs); and Workshop on SAI Performance Measurement Framework (SAI PMF) for Future Assessors. More details about the projects can be seen in the slide presentation as attached in **ANNEX 5a**.
- 6.3.2 Ms. Tolentino also presented success stories of the ISSAI Implementation Programme on ASEANSAI (Long Term ASEANSAI Programme on ISSAI Implementation – LTAPII). She presented the success factor of LTAPII which involved ASEANSAI internal capacity (ISSAI Facilitators and Training Specialist of IDI, IT infrastructure, strong leadership and commitment of capacity building),

commitment and support of external partners (financial support from GIZ and World Bank) and technical assistance from Swedish National Audit Office (SNAO). The presentation slide as attached in **ANNEX 5b.**

6.4 Presentation of Knowledge Sharing Committee

- 6.4.1 The Honorable Mr. Hendar Ristriawan invited Mr. Roslan bin Abu Bakar from SAI Malaysia as the representative of the Chair of ASEANSAI Knowledge Sharing Committee to present the prioritized projects of ASEANSAI Knowledge Sharing Committee.
- 6.4.2 In his presentation, Mr. Roslan explained two prioritized project from ASEANSAI Knowledge Sharing Committee, which are good practices on SAI independence and sustainable development related issues. More details about the projects can be seen in the slide presentation as attached in **ANNEX 6**.

6.5 **Discussion**

- 6.5.1 After the presentations on the prioritized projects by ASEANSAI Committees, The Honorable Mr. Hendar Ristriawan invited all donors to give questions for the committees. Further, he introduced Mr. R. Yudi Ramdan from the ASEANSAI Secretariat to assist him in moderating the discussion.
- 6.5.2 Mr. Trygve Christiansen from SAI Norway expressed its interest to the implementation of SAI Performance Measurement Framework (PMF). SAI Norway is of the view that it would be very interesting to have a dialogue and they were offering support in kind to increase awareness in the region and in carrying out self assessment. They recognized the tools as new tools and sometimes can be sensitive for implementation.
 - SAI Norway sought clarification on whether ASEANSAI has concrete activities on how to implement the tools or to increase awareness and how the activities will relate to the IDI.
- 6.5.3 Ms. Tolentino clarified that since the decisions lies with the respective Auditor-General, the SAI should be building the awareness first to convince the Auditor-General before proceeds further. She opined that creating awareness is a good strategy then self-assessment and followed by improving the SAI performance.

6.5.4 Mr. Srinivasan Janardanam from ADB commented on the process of SAI PMF application. SAI PMF is intended to be self assessment by the Auditor General then as a follow on to that, strategy and action plan developed which can be implemented appropriately depending on the issue of sensitivity.

He also mentioned another issue faced by the ADB related to accountability of project financial reporting and auditing which experienced delay in reporting and interfered with the quality and use of the report.

- 6.5.5 Ms. Karin Holmerin from Swedish National Audit Office (SNAO) offers the possible contribution from SNAO to ASEANSAI, based on the needs of ASEANSAI committees for outside expertise and area of support.
 She also suggested the strategy on how to deal with the issue of sensitivity on the implementation of SAI PMF. Rather than to reveal the conclusion, it would be more beneficial to discuss the experience, process and how to manage it.
- 6.5.6 Ms. Tolentino pointed out the need from Training Committee that the expert needed would be based on the result of self-assessment, prioritization and identification.
- 6.5.7 Mr. Roslan from Knowledge Sharing Committee emphasized the ISSAI-based activities conducted by the ASEANSAI. Therefore, the expertise is expected to be knowledgeable on ISSAI and enriched with experience. He highlighted the importance of the expert to boost the confidence and good exposure to learn from developed country.
- 6.5.8 Ms. Binh from Strategic Planning Committee emphasize the need to upgrade the Monitoring and Evaluation System (MES), she intend to develop different tools to set the Key Performance Indicator (KPI) including setting of appropriate baseline.
- 6.5.9 Mr. Daniel Blessing from GIZ expressed its interest to continue the support to upgrade the MES and sought clarification on whether there will be longer term project for the Audit on Public Procurement or it will be scaled at the bilateral level.

- 6.5.10 Ms. Tolentino responded to GIZ by explaining that there is a need for the Follow Up Workshop on Audit of Public Procurement (FUWAPP) to expand its participants to ensure the involvement of SAIs.
- 6.5.11 Ms. Holmerin confirmed to support ASEANSAI by providing expert especially in relation to the Strategic Plan. She mentioned the need to provide clear timing for the support needed to arrange availability of the expert.
- 6.5.8 In the end of the discussion session, Mr. Ramdan concluded that
 - Some donors expressed its interests on the following:
 - SAI Norway offers to provide expertise on SAI PMF through sharing of experience
 - 2) SAI Sweden offers to continue supporting the LTAPII and to provide expertise on Strategic Plan to assist ASEANSAI Strategic Planning Committee (SPC) develop the next strategic plans.
 - 3) GIZ offers its support for upgrading the MES.
 - ❖ To manage the relationship with the donors, it was agreed to conduct two main activities, which are focus on the coordination and information among donors working with SAI in ASEAN and ASEANSAI; and the support to ASEANSAI as organization and its regional activities.
 - ❖ In coordinating and sharing information among donors working with SAI in ASEAN and ASEANSAI, it is planned to be done by sharing information via ASEANSAI newsletter, and developing an information-portal for the ASEANSAI-Donor forum that will be included in the ASEANSAI website.
 - In the future, the information-portal will contain information on capacity building program undertaken by ASEANSAI including the information on support by the relevant donors as well as the information on any bilateral or multilateral cooperation between ASEANSAI member SAI and donors.
 - ❖ The ASEANSAI Secretariat will be in the lead to create the information portal and expect input from each of the development partner to achieve a comprehensive overview on the activities.

In focusing on support to ASEANSAI as organization and its regional activities, it was agreed that a scoping mission is an initial activity that must be conducted before donors support ASEANSAI. It aims to match the expectation between the donors and ASEANSAI, and can define the area of cooperation and clarify the needs of the SAI. In the future, the ASEANSAI Secretariat will assist to arrange the missions jointly with the relevant committee chairs and serve as an entry point for donors. Further, ASEANSAI Strategic Plan will be the outline for the scoping missions.

7. CLOSING

- 7.1 The Honorable Mr. Hendar Ristriawan expressed his satisfaction on the meeting results. He pointed that all attendees need to agree on the technical details of the new foundation between donors and ASEANSAI. The ASEANSAI Secretariat will contact all attendees to move forward on the issue.
- 7.2 Further, as the Head of the ASEANSAI Secretariat, he conveyed his appreciation for the active participation of all attendees in the 2017 ASEANSAI Donor Coordination Meeting.

MINUTES OF ASEANSAI TEHNICAL MEETING 5th November 2017

Landmark Mekong Riverside Hotel, Vientiane, Lao PDR

1. DATE AND VENUE

- 1.1. The ASEAN Supreme Audit Institutions (ASEANSAI) Technical Meeting was held on 5th of November 2017.
- 1.2. The event took place in Diamond Room, Landmark Mekong Riverside Hotel, Vientiane, Lao PDR

2. PARTICIPANTS OF THE ASEANSAI TECHNICAL MEETING

- 2.1. The ASEANSAI Technical Meeting was attended by 29 senior officials / delegates from:
 - i) Jabatan Audit Brunei Darussalam (SAI Brunei);
 - ii) National Audit Authority of Kingdom of Cambodia (SAI Cambodia);
 - iii) The Audit Board of the Republic of Indonesia (SAI Indonesia);
 - iv) The State Audit Organization of Lao P.D.R. (SAI Lao);
 - v) Jabatan Audit Negara Malaysia (SAI Malaysia);
 - vi) Office of the Auditor General of the Union, the Republic of the Union of Myanmar (SAI Myanmar);
 - vii) The Commission on Audit of the Republic of Philippines (SAI Philippines);
 - viii) Auditor-General's Office of Singapore (SAI Singapore);
 - ix) Office of the Auditor General of Thailand (SAI Thailand); and
 - x) State Audit Office of Vietnam (SAI Vietnam)

3. TECHNICAL MEETING

3.1. The Honorable Mr. Hendar Ristriawan, Head of Secretariat Function of ASEANSAI welcomed all attendees to the ASEANSAI Technical Meeting. Mr. Ristiawan mentioned that the meeting functioned as a preparatory meeting to ensure the 4th ASEANSAI Summit held in the next day would run smoothly. Then, Mr. Ristiawan presented four agenda to be discussed in the meeting.

The presentation slides can be seen in ANNEX 2.

4. Agenda 1: Revised ASEANSAI Rules and Procedures

- 4.1. Mr. Ristiawan pointed out that based on decision made during The 4th Senior Officials Meeting (SOM) on 4th 5th of August 2017, the ASEANSAI Rules and Procedures was to be revised. Mr. Ristiawan reminded that following the decision, the Rules and Procedures Committee (RPC) circulated draft of the revised ASEANSAI Rules and Procedures to all ASEANSAI members on 28th of August 2017. There were no objections received from the ASEANSAI members to the revised ASEANSAI Rules and Procedures.
- 4.2. Mr. Ristiawan highlighted that based on the due process, the revised ASEANSAI Rules and Procedures was considered final and ready to be endorsed in the 4th ASEANSAI Summit the next day.

5. Agenda 2: Appointment and Approval of the Secretariat of ASEANSAI

- 5.1. Mr. Ristiawan stated that based on decision made during the 4th SOM on 4th 5th of August 2017, the ASEANSAI members agreed on the appointment of SAI of Indonesia to be the longer term ASEANSAI Secretariat for period 2017 2023. As SAI of Indonesia has met requirements stated in the revised ASEANSAI Rules and Procedures, SAI of Indonesia could function legally as the longer term Secretariat of ASEANSAI.
- 5.2. Mr. Ristiawan said that the appointment would be endorsed in the 4th ASEANSAI Summit, Agenda 3 of Meeting Session I the next day.

6. Agenda 3: Confirmation on the ASEANSAI Strategic Plan of 2018 - 2021

- 6.1. Mr. Ristiawan said that the 3rd Agenda of this Technical Meeting was confirmation on the ASENSAI Strategic Plan of 2018 2021 and its Implementation Matrix. Then, Mr. Ristiawan invited Ms. Do Thi Binh from SAI of Vietnam to make presentation on the ASEANSAI Strategic Plan of 2018 2021 and the Implementation Matrix.
- 6.2. Ms. Binh pointed out that the session of the technical Meeting is the final review for the Implementation Matrix which will be endorsed at the Summit. She went through the latest draft of Strategic Plan and sought confirmation from the Committees for the Implementation Matrix.
- 6.3. The Meeting agreed on the final version of the Mission, Vision, Strategic Goals and Strategic Objectives. The discussion mainly focused on the implementation matrix.
- 6.4. The adjustments made to the proposed implementation matrix are as follows:
 - a. Additional activity for the Interim Wrap up Meeting on the Long-term ASEANSAI Programme on ISSAI Implementation (LTAPII) rescheduled from December 2017 to January 2018 to be conducted in Manila, Philippines.
 - b. Clarification from Mr. Roslan for the activity number 2 under the KPI 1.2.1, Project Evaluation Meeting at Senior Officials Level is the same activity as the Interim Wrap up Meeting. Therefore, in the implementation matrix will be amended as "Project Evaluation Meeting at Senior Officials Level/ Wrap Up Meeting for LTAPII"
 - c. Deletion of the activity number 2 under the KPI 2.1: Knowledge sharing on SAI PMF application (Independence domain excluded).
 - d. Additional activity for the KPI 2.2, Fraud Audit Workshop which will be held in Jakarta in 2018.
 - e. Pending confirmation from SAI Lao for the Host SAI to conduct Knowledge Sharing Workshop on audit of SDGs.
- 6.5. After the presentation, Mr. Ristiawan thanked Ms. Binh and asked the ASEANSAI members whether further clarification was required on the ASEANSAI Strategic Plan of 2018 2021 and the Implementation Matrix.

6.6. Since there were no further comments from the ASEANSAI members, Mr. Ristiawan concluded that the ASEANSAI Strategic Plan 2018 – 2021 and the Implementation Matrix was ready to be endorsed in the 4th ASEANSAI Summit the next day.

7. Agenda 4: The Result of Donor Coordination Meeting (DCM)

- 7.1. Mr. Ristiawan commenced the 4th Agenda of the Technical Meeting by explaining briefly about the Donor Coordination Meeting (DCM) held on 5th of November 2017 at 09.00 12.30 before the Technical Meeting:
- 7.1.1.The DCM was attended by 44 participants and 6 donor organizations such as, Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ), World Bank (WB), Asian Development Bank (ADB), Swedish National Audit Office (SNAO), SAI of Norway, and European Union (EU).
- 7.1.2.The DCM purposed to promote the ASEANSAI profile to the donors, to build network between ASEANSAI and the donors, and to provide opportunity for further cooperation between ASEANSAI and the donors and between ASEANSAI members and the donors.
- 7.1.3.Committees of the ASEANSAI presented the potential programs on their Work Plans so that the donors could obtain understanding on how to give the most contribution to ASEANSAI and to the ASEANSAI members.
- 7.1.4. During the meeting, some donors expressed their interest in some proposed activities of ASEANSAI:
 - a. SAI of Norway offers to provide expertise on SAI Performance Measurement Framework (PMF);
 - b. Swedish NAO offers to continue supporting the LTAPII and to provide expertise on Strategic Plan to assist ASEANSAI Strategic Planning Committee (SPC) develop the next strategic plans.
 - c. GIZ offers its support for upgrading the Monitoring and Evaluation System (MES).
- 7.2. Mr. Ristiawan pointed out that the DCM had brought all required information, experience, and expertise from ASEANSAI members and the donors that showed

mutual interest on cooperation. Mr. Ristiawan highlighted that the donors explicitly expressed their willingness to support ASEANSAI, therefore ASEANSAI needed to build a robust communication platform for further cooperation with the donors.

- 7.3. Mr. Ristiawan continued to explain that ASEANSAI and ASEANSAI Secretariat would develop the robust communication platform in two activities:
 - a. The first activity is the coordination and information among donors working with SAI in ASEAN and ASEANSAI by developing portal of communication. ASEANSAI planned to develop an information portal to be included in the ASEANSAI website to function as the ASEANSAI-Donor Forum. It would provide information on the supports being provided by the donors, the activities being carried out by ASEANSAI and its members, and bilateral or multilateral cooperation between ASEANSAI members and the particular donors.
 - b. The second activity was organizing scooping mission to support ASEANSAI. This activity aimed to match expectation of ASEANSAI and the donors, defining the area of cooperation needed by ASEANSAI members. The Strategic Plan of ASEANSAI could serve as an outline for the scooping mission. ASEANSAI Secretariat would assist to organize the scooping mission jointly with related Committee Chairs. The mission would be an entry point for the donors to support the ASEANSAI.
- 7.4. Mr. Ristiawan invited the meeting participants for discussion on developing communication platform between ASEANSAI and the donors. This discussion was led by Mr. Yudi Ramdan Budiman from Secretariat Function of ASEANSAI.
- 7.4.1. Some matters highlighted during the discussion are:
 - a. Ms. Tolentino suggested that the prioritized project proposed by the Committee is linked each other, it will not stand alone but should be coordinated in a holistic manner.
 - b. Mr. Roslan pointed out on how to match the expectation between donors and ASEANSAI in order to obtain support for financing the ASEANSAI activities.
 - c. Mr. Sophat informed that different donors will offer different scheme of support. It depends on the proposal from ASEANSAI.
 - d. Mr. Yudi highlighted the importance of financial sustainability after the support from GIZ and World Bank ended in 2018. Therefore secretariat see the need to establish

the communication platform between ASEANSAI and Donors to maintain relation which will lead to engagement or cooperation for supporting ASEANSAI.

- 7.4.2. The discussion acknowledged the need for the donors' support to ASEANSAI.
- 7.4.3. The support would be managed accordingly to ensure efficient arrangement for the donors. Therefore, ASEANSAI Secretariat proposed to develop the communication platform between ASEANSAI and the donors.
- 7.4.4. The proposal to develop the communication platform would be reported in the ASEANSAI Summit on the next day for approval.

8. CONCLUSION

- 8.1. The Honorable Mr. Hendar Ristriawan, Head of Secretariat Function of ASEANSAI, thanked Mr. Yudi Ramdan Budiman for leading discussion on developing communication platform between ASEANSAI and the donors and for presenting the 5th Agenda of the Technical Meeting.
- 8.2. Mr. Ristiawan concluded the Technical Meeting as follows:
 - The revised ASEANSAI Rules and Procedures would be endorsed in the Assembly of the 4th ASEANSAI Summit.
 - The appointment of SAI Indonesia as the longer term ASEANSAI Secretariat would be endorsed in the Assembly of the 4th ASEANSAI Summit. SAI Indonesia would legally function as the longer term ASEANSAI Secretariat.
 - 3. The ASEANSAI Strategic Plan of 2018-2021 would be endorsed in the Assembly of the 4th ASEANSAI Summit.
 - 4. The issue that the ASEANSAI Secretariat would manage the establishment of the donor communication platform would be reported in the 4th ASEANSAI Summit.
 - 5. The Agenda of the 4th ASEANSAI Summit would be for endorsement on the agreed issues as agreed in the SOM.

9. CLOSING

- 9.1. The Honorable Mr. Hendar Ristriawan, Head of Secretariat Function of ASEANSAI, thanked all the attendees of the Technical Meeting and expected that the 4th ASEANSAI Summit held in the next day would run smoothly.
- 9.2. There were no other matters, the Technical Meeting ended at 04.00 PM.

1. DATE AND VENUE

- 1.1 The 4th ASEAN Supreme Audit Institutions (**ASEANSAI**) Summit was held on 6th November 2017.
- 1.2 The event took place in Grand Ballroom, Landmark Mekong Riverside, Vientiane, Lao PDR.

2. PARTICIPANTS OF THE ASEANSAI SUMMIT

- 2.1 The 4th ASEANSAI Summit was attended by 60 delegates from:

3. WELCOMING ADDRESS BY THE VICE CHAIRPERSON OF ASEANSAL

- 3.1 Her Excellency Dr. Viengthong SIPHANDONE, Vice Chairperson of ASEANSAI and President of State Audit Organization of Lao PDR delivered her Welcoming Address.
- 3.2 In her speech, Her Excellency Dr. Viengthong SIPHANDONE:
 - Emphasized that ASEANSAI has continually developed itself by investing in technical capacity building and development of public audit for all member of ASEANSAI.
 - Highlighted that ASEANSAI has emphasized and regarded the internal and external cooperation as the key to improving its role regionally and internationally.
 - ❖ ASEANSAI has successfully tailored and implemented the ASEANSAI Strategic Plan 2014-2017. A number of productive activities have been conducted through the Action Plan of the relevant Committees.
 - ❖ Expected that the upcoming Strategic Plan 2018 2021 will be able to strengthen capacity and to promote cooperation among the member SAIs.

4. OPENING ADDRESS BY THE CHAIRPERSON OF ASEANSAL

- 4.1 Her Excellency Madam Som Kim Suor, Chairperson of ASEANSAI and Auditor General of National Audit Authority of Cambodia delivered the Opening Address.
- 4.2 In her speech, Her Excellency Madam Som Kim Suor
 - ❖ Conveyed a brief accomplishment made by the ASEANSAI since the 3rd ASEANSAI Summit in November 2015 in Cambodia. Those accomplishments cannot be reached without participations and contributions of SAI members,

- governments of each respective SAIs members together with the Development Partners.
- Stated common challenges that ASEANSAI has to face and require collaboration from all members, such as financial constraints for activities implementation, restructuring of the Secretariat, the implementation of the Strategic Plan 2018-2021 and the application of the Principle of Consensus which demands more time and resources because of each SAI member's different procedures and needs. However, differences in language and tradition require a compromise among the ASEANSAI members.
- ❖ Took the opportunity to express her sincere gratitude to all heads of SAI members and partners for the supports and for the invaluable inputs during her tenure.

5. SPEECH BY THE CHAIR OF ASOSAI

- 5.1 His Excellency Datuk Juhari bin Haron, Representative Chairman of ASOSAI and Deputy Auditor General of Malaysia delivered the speech.
- 5.2 In his speech, His Excellency Datuk Juhari bin Haron:
 - Stated that ASOSAI has made progress and achievements in promoting greater efficiency, accountability, effectiveness and transparency have found its place in the United Nations General Assembly Resolution A/66/209 and United Nations Post 2015 Agenda
 - Informed that ASOSAI has constantly supported its member SAIs in achieving its goals through two main pillars, which are capacity development initiatives and fruitful knowledge sharing.
 - ❖ The role of SAIs in auditing government activities will always have the support from ASOSAI. Therefore, ASOSAI will always create opportunities to collaborate with INTOSAI and ASEANSAI Community.
 - Finally, ASOSAI welcomes any form of collaboration from ASEANSAI especially on the auditing of the United Nations Agenda 2030: Sustainable Development Goals or SDGs.

6. SPEECH BY ASEAN SECRETARIAT

- 6.1 His Excellency Mr. AKP Mochtan, Deputy Secretary General of ASEAN delivered the speech.
- 6.2 In his speech, His Excellency Mr. AKP Mochtan:
 - Emphasized that ASEANSAI can play pivotal role in strengthening ASEAN's governance, which subsequently contributes to the regional integration process.
 - Wished to call on the ASEANSAI to explore the prospect to be auditor for the ASEAN Secretariat
 - Stated that the ASEANSAI's role in developing capacity of Supreme Audit Institutions of ASEAN Member States and strengthening technical cooperation to deal with common audit issues with a view to enhancing good governance in the ASEAN region is indispensable.
 - Expressed support to ASEANSAI and ASEANSAI Secretariat in the new year of chairmanship.

7. SPECIAL ADDRESS BY DEPUTY PRIME MINISTER OF THE LAO PDR

- 7.1 His Excellency Mr. Sonexay SIPHANDONE, Deputy Prime Minister of the Lao PDR delivered the Special Address.
- 7.2 In his speech, His Excellency Mr. Sonexay SIPHANDONE:
 - ❖ Iterated ASEAN has initiated regional cooperation mechanisms which provided a solid platform for ASEAN's engagement with Dialogue Partners and external parties. It also created opportunities to engage with one another on important

- regional and global issues with a view to find appropriate ways and means to enhance cooperation and address common challenges together.
- ❖ Highlighted that ASEAN has recognized the important role of ASEANSAI in translating the Blueprints into policies, programs, and projects in line with the respective legislation of ASEAN Member States. This role has been incorporated as one of the cooperation areas within the ASEAN Community Vision 2025.
- ❖ Emphasized that one of the important responsibilities of the Supreme Audit Institutions is the promotion of anti-corruption in the functioning and governance of the state which will enhance trust and confidence of the public as well as domestic and foreign investors. Most importantly it will support the development of the ASEAN Community through strengthening good governance and transparency in the public sector.
- Expected that the Summit will provides a great opportunity to agreed upon future actions towards contributing to the effective realization of ASEAN Community Vision objectives including strengthening the rule of law, maintaining financial and monetary stability, implementation of socio-economic development plans, the fight and prevention against corruption, and promotion of investment, among others.

- 9.2 In his speech, Dr. Harib Saeed Al Amimi:

- Highlighted the importance of engagement between regional and sub regional organization. In the global level, the regional and sub regional is expected to assist SAIs in the coordinated and professional manner.
- ❖ Emphasized the challenge of SAIs is to meet the increasing demands from the stakeholders for professional and quality audits. To fulfill this demand, many countries will need assistance from the regional and sub regional organization. The main challenge is to make the capacity sufficient to provide the expertise and technical support suitable with the SAI's need.
- ❖ Believed that by understanding the global standard and providing tools to SAIs to meet the requirement should be implemented to regional and sub regional responsibility. It is a challenge but INTOSAI will seek to support ASEANSAI through various channels.
- ❖ Taken note of the IDI' role in ASEAN region and encouraged more linkages (such as financial auditing and accounting subcommittee which is chaired by SAI UAE). He found the importance to support one another.
- Wished the success of ASEANSAI Summit and awaiting for the outcome.

10. 4th ASEANSAI SUMMIT MEETING SESSION I

- 10.1 Her Excellency Madam Som Kim Suor chaired the 4th ASEANSAI Summit and opened the meeting by highlighted remarkable achievements of the ASEANSAI. She also extended her appreciation and admiration to all ASEANSAI committees, Secretariat Function and Administration Function.
- 10.2 She gave a brief acknowledgment on the recent development by each ASEANSAI Committee. Then she moved to the meeting agenda items for the Meeting Session I.

 - ❖ Highlighted the new SP will focus on continuing capacity development, promoting good practices, strengthening ASEANSAI's role and influencing actively in the region and knowledge sharing.
 - ❖ Informed that during the period, SPC has well performed its responsibilities in terms of both carrying out its primary mandate and coordinating with the Secretariat in monitoring the implementation of the SP.

 - Highlighted that the revised Rules and Procedures will better serve the needs of ASEANSAI and provide useful guidance on ASEANSAI's financial, administrative and secretariat matters.
 - Extended his sincere gratitude to the members of the Rules and Procedures Committee for their contributions and their willingness to be reappointed as Committee members in work years 2018 and 2019.

11.3 Report by Chair of Knowledge Sharing Committee

- 11.3.1 His Honorable Mr. Roslan bin Abu Bakar, Director of Research, Corporate and International Affairs Division JAN Malaysia and Representative Chairman of ASEANSAI Knowledge Sharing Committee (KSC):
 - ❖ Reported that nine projects were completed under KSC in 2016, consist of three series of Focus Group Discussion on Research in Revenue Audit, one Knowledge Sharing Project on Audit of Health Services, one Workshop on

Public Private Partnership and 4 series of Long Term ASEANSAI Programme on ISSAI Implementation (LTAPII).

- The three series of FGDs are completed and the Research Project Report on Revenue Audit and the ASEANSAI Guideline on Revenue Audit as the outcome has been published.
- 2) Knowledge Sharing Project on Audit of Health Services involved sharing knowledge about research on Health Services Auditing and National Health Security, Techniques/Audit Procedures of National Social Security System and Lesson Learned from Performance Auditing on National Health Security at General Public Hospital. Other participating SAIs also has successfully presented their country papers.
- 3) The project has successfully gathered experts in such field such as university professors, researchers, economists, engineers, prosecutors and anti-corruption agencies to contribute their perspectives in PPP Project. Five critical topics were extensively discussed namely; PPP and the importance of auditing economic value added project; overview of auditing PPP; legal perspectives and macroeconomic policy; promoting good governance in PPP and sharing audit experiences in PPP project.
- ❖ Reported that nine projects were completed under KSC in 2016, consist of Focus Group Discussion on Audit of Revenue, Knowledge Sharing Project on Audit of Health of Services, Workshop on Public Private Partnership and the Long-Term ASEANSAI Programme on ISSAI Implementation (LTAPII).

 - ❖ His Honorable Dr. Hendar Ristriawan, reported the activities conducted by the Secretariat in the duration of 2015 – 2017 in the following roles and responsibilities:
 - 1) Responsible to the Chairperson of ASEANSAI by submitting of the activity report through Executive Committee.

- 2) To assist the Executive Committee in managing the work of the Assembly through facilitating various meeting, collaborating with SPC to encourage alignment of Committee' Work Plan with ASEANSAI Strategic Plan, compiling the ASEANSAI budget 2018 – 2019 based on inputs from the Committees.
- 3) To manage the finances of ASEANSAI by preparing the Financial Statement for year ended 31 December 2016 and Interim Financial Statement as of September 2017 which disclosed funds received from the Annual Contribution and from the donors.
- 4) To keep record and documents of ASEANSAI
- 5) To maintain communication with external parties by informing the result of the Donor Coordination Meeting held on 5 November 2017. Secretariat is planning to establish foundation for the communication platform with donors. The platform will involve coordination and information among donors working with SAIs in ASEAN and ASEANSAI (through portal of communication) and scooping mission (as initial engagement with the donors).
- 6) To perform any other duties as directed by the Executive Committee.

- 12. Agenda 2: Approval of the Revised Rules and Procedures of ASEANSAI

- 12.1 Her Excellency Madam Som Kim Suor recapped that the Rules and Procedures have been revised following the signing of the protocol on amending the ASEANSAI Agreement in December 2016 which paved the way for the establishment of a longer Secretariat with 6-year term.
- Her Excellency Madam Som highlighted that as a result of the above, Rule and Procedures Committee has revised the ASEANSAI's Rules and Procedures which was adopted in the 2nd ASEANSAI Summit in 2013.
- 12.3 Her Excellency Madam Som also emphasized that the revised Rules and Procedures were discussed and agreed at the 4th ASEANSAI Senior Officials' Meeting in August, 2017 in Siem Reap, Cambodia with some additions and supplementation to the existing Rules and Procedures as follows:
 - Adding paragraph 1.5 related to seeking comments and decision from the ASEANSAI Assembly
 - Editing paragraph 1.11 related to notification on the termination of ASEANSAI membership.
 - Editing paragraph 4.8 related to the work plan of each committee to be aligned with the ASEANSAI Strategic Plan and adding paragraph 4.16 related to the Monitoring and Evaluation System of ASEANSAI
 - Revising Part 5 regarding the nomination and procedure for appointing the Secretariat, its function and resources for the Secretariat's operations
 - Adding Part 10 related to Protection of Intellectual Property Right to be in line with Article 2 of the Protocol Amending the Agreement on the Establishment of ASEANSAI.
- 12.4 The Assembly approved the revised Rules and Procedures which can be seen in **ANNEX 14**.

13. Agenda 3: Appointment and Approval of the ASEANSAI Secretariat

13.1 Her Excellency Madam Som Kim Suor iterated Paragraph 5.2 of the ASEANSAI Rules and Procedures which has been approved under the previous Agenda item, which stated that:

- during the transitional period, the Assembly could retain the existing Secretariat to continue their work until the appointment of the new Secretariat.
- Her Excellency Madam Som Kim Suor recalled that the 4th Senior Officials' Meeting had agreed to support SAI Indonesia self-nomination to be the Secretariat for 2018-2023 and the appointment will be approved in the 4th ASEANSAI Summit.
- 13.3 The Assembly approved of the appointment of SAI Indonesia as the Secretariat for 2018-2023.
- 13.4 H.E. Dr. Moermahadi Soerja Djanegara, Chairman of the Audit Board of the Republic of Indonesia conveyed a statement:
 - Expressed his appreciation to all ASEANSAI members, for entrusting SAI Indonesia to be the long term ASEANSAI Secretariat for the period of 2018 2023.
 - ❖ Assured that SAI Indonesia will continue its commitment as the driving force and maintain the sustainability of ASEANSAI for the benefit of all its members.
 - Stated that SAI Indonesia will submit all requirements and documents needed as the long term Secretariat in accordance with the revised rules and procedures.
- 13.5 Her Excellency Madam Som Kim Suor expressed her gratitude to SAI Indonesia for its commitment.

14. Agenda 5: Appointment of New Chairperson and Vice-Chairperson of ASEANSAI for 2017-2019

- 14.1 Her Excellency Madam Som Kim Suor iterated Article 6 of the Agreement on the Establishment ASEANSAI stating that:
 - Appointment of the Chairman and Vice Chairman is rotated in alphabetical order of country name unless decided otherwise by the Assembly;
 - The term of office of the Chairman of ASEANSAI shall be for two years; and
 - The Vice Chairman shall be the next Chairman.

- 14.2 Her Excellency Madam Som Kim Suor highlighted that based on the result of the 4th Senior Officials' Meeting, State Audit Organization of Lao PDR accepted to be the Chair of ASEANSAI and Jabatan Audit Negara Malaysia will be the Vice Chair for the period of 2017 to 2019.
- 14.3 Her Excellency Madam Som Kim Suor invited the Assembly to approve the appointment of State Audit Organization of Lao PDR as Chair and Jabatan Audit Negara Malaysia as Vice Chair of ASEANSAI from 2017 to 2019.
- 14.4 The meeting approved the appointment of the State Audit Organization of Lao PDR as the Chair of ASEANSAI and Jabatan Audit Negara Malaysia as the Vice Chair of ASEANSAI.
- 14.5 Her Excellency Madam Som Kim Suor then officially handed over the ASEANSAI Chairmanship by handing over the ASEANSAI Gavel and an ASEANSAI Book entitled "Spirit of togetherness for Achievement" to Her Excellency Dr. Viengthong Siphandone, President of SAI Lao PDR.

15. 4th ASEANSAI SUMMIT MEETING SESSION II

- Her Excellency Dr. Viengthong SIPHANDONE, newly appointed Chairperson of ASEANSAI and President of State Audit Office of Lao PDR delivered the opening address:
 - Extended her appreciation to the outgoing Chairperson of ASEANSAI, H.E. Madam Som Kim Suor and her gratitude to all committees for their immense achievements.
 - Encouraged the close-knit cooperation from all parties to achieve the ASEANSAI's objectives
 - ❖ Invited all of head of SAIs and all the international organizations to broaden knowledge sharing and capacity development of ASEANSAI and to address the current challenges encountered by the ASEANSAI community.

- 15.2 His Excellency Dato Juhari bin Haron, representative of newly appointed Vice Chairperson of ASEANSAI and Deputy Auditor General Jabatan Audit Malaysia delivered the remarks:
 - Expressed that SAI Malaysia has been looking forward to expand its vast knowledge and experiences. Also iterated that ASEANSAI members are not only close to each other geographically, but also close at heart as the ASEANSAI family.
 - Sought cooperation from ASEANSAI members to render its supports.

- 15.3 Her Excellency Dr. Viengthong SIPHANDONE chaired the Meeting Session II and started the meeting by recalling the result of the Meeting Session I.
- 15.4 Her Excellency Dr. Viengthong SIPHANDONE mentioned the remaining agenda items for the meeting session II:
 - ❖ Approval of the ASEANSAI Strategic Plan 2018 2021
 - ❖ Appointment and Approval of ASEANSAI Committees
 - Appointment and Approval of ASEANSAI Auditor for Financial Statements for Year Ended 2016 and 2017
 - ❖ Presentation and Approval of ASEANSAI Committees' Work Plans, and Budget Plan of the ASEANSAI Secretariat for the period 2018 – 2019
- 15.5 The meeting participants approved the agenda of the Meeting Session II.

16. Agenda 5: Approval of the ASEANSAI Strategic Plan 2018 – 2021

- 16.1 Her Excellency Dr. Viengthong SIPHANDONE recalled that the process of the development of ASEANSAI Strategic Plan 2018 2021 started since August 2016. She mentioned that SAI Vietnam as the Chair of the Committee has circulated the draft to all members SAIs and incorporated inputs received from the circulation into the draft Strategic Plan.
- Her Excellency Dr. Viengthong SIPHANDONE stated that the final draft has been presented and agreed upon during the 4th Senior Official Meeting.

- 16.3 Ms. Ha Thi My Dung presented the final draft of the Strategic Plan on behalf of Chair of Strategic Planning Committee.
 - ❖ Informed that based on the 4th SOM in August 2017, SAI Vietnam as SPC Chair has incorporated all contributions from its members and Committees' Chairs to finalize the last version. The contributions were mainly the adding in term of activities, budget and time to implement projects and activities led by Committees' Chairs.
 - ❖ Presented the agreed Strategic Goals (SG) and Strategic Objectives (SO) and highlighted that during period of 2018 − 2021, ASEANSAI will put its focus on continuing capacity development, pushing up the communication channels with ASEAN and international partners, supporting member SAIs to utilize performance related tools and concepts as well as conducting SDG- related auditing that align with INTOSAI efforts in launching capacity development programs on SDGs. In addition to that, the improvement of organizational governance of ASEANSAI is of high priority.
 - Highlighted the implementation of the SP will be performed in selective and efficient manner.
 - Encouraged the distribution of activities/ projects under each SG and SO.

- 17.3 Her Excellency Dr. Viengthong SIPHANDONE also informed that the Committees' membership for the period of 2018 2019 remains the same as the previous committees'. The current composition of the ASEANSAI committees:
 - Strategic Planning Committee
 SAI Vietnam is the Chair and it has a total of six members which are SAI Brunei,
 Indonesia, Lao PDR, Malaysia, Philippines and Thailand.
 - Rules and Procedure Committee
 SAI Singapore is the Chair and the four members are SAI Brunei, Lao PDR, Malaysia and Thailand.
 - Knowledge Sharing Committee
 SAI Malaysia is the Chair and there are seven members which are SAI Brunei,
 Cambodia, Lao PDR, Myanmar, Philippines, Thailand and Vietnam.
 - ❖ Training Committee SAI Philippines is the Chair with four members, SAI Brunei, Indonesia, Malaysia and Thailand.
- 17.4 The Assembly approved the membership of the ASEANSAI Committees for the period 2018 2019.

18. Agenda 7: Appointment and Approval of ASEANSAI Auditor for Financial Statements for Year Ended 2016 and 2017

- 18.1 Her Excellency Dr. Viengthong SIPHANDONE:
 - Expressed her gratitude to Office of the Auditor General of Thailand for their valuable time and immense effort in auditing the ASEANSAI's financial statements for the year ended 31 December 2014 and 31 December 2015.
 - ❖ Restated the result of the 4th Senior Officials' Meeting that Office of the Auditor General of Thailand has expressed its interest to become the auditor for the ASEANSAI's financial statements for the year ended 31 December 2016 and 31 December 2017.
 - ❖ Iterated the ASEANSAI Rules and Procedures paragraphs [9.42 and 9.43 that Members of ASEANSAI (other than those in the Executive Committee and

- Secretariat) may volunteer to be the auditor, which may also be re-appointed, subject to the approval of the Assembly.
- Invited the Assembly to approve SAI Thailand to be re-appointed as the Auditor for ASEANSAI financial Statements for the year 2016 and 2017.
- 18.2 The Assembly approved the re-appointment of SAI Thailand as the Auditor for ASEANSAI Financial Statements for the year ended 31 December 2016 and 31 December 2017.
- 18.3 His Excellency General Chanathap Indamra, Chairman of the State Audit Commission of Thailand gave his confirmation of acceptance for the appointment as the ASEANSAI Auditor for the year ended 31 December 2016 and 31 December 2017.

19. Agenda 8: Presentation and Approval of ASEANSAI Committees' Work Plans and Budget for 2018 – 2019

19.1 Excellency Dr. Viengthong SIPHANDONE invited the Committees to present the work plan for 2018 – 2019.

 - ❖ Delivered the consideration for need to review and upgrade Monitoring and Evaluation System (MES) for better application based on the result of SPC's identification:
 - 1) The MES was unable to capture comprehensive picture of ASEANSAI activities with full information.
 - 2) The difference in level of understanding on the application of the MES among the committees which led to invalid measuring activity/event conducted
 - 3) The Key Performance Indicator (KPI) approach was unable to produce qualified annual Monitoring and Evaluation (M&E) Report to provide sufficient information in setting the baseline/target.

 - Invited Honorable Dr. Hendar Ristriawan, Secretary General Audit Board of the Republic of Indonesia and Head of Secretariat Function to explain the details of Secretariat Work Plan.

19.7.2 Honorable Dr. Hendar Ristriawan presented:

- to promote safeguarding the independence of member-SAIs and in particular on how this intersects with the ASEAN Inter-Parliament Assembly (AIPA) by conducting meetings/joint seminars on the importance of SAI independence with AIPA
- ❖ to extend and strengthen the existing relations with ASEAN and the ASEAN Economic Agenda (AEC) by building of connections within ASEAN region which can deliver a wider and solid common purpose, for SAI independence, and in other critical areas.
- to expand cooperation with international SAI partners, stakeholders and international donors by building stronger communication and coordination mechanisms with ASOSAI and INTOSAI, including establishing MoUs, will help integrate procedures and provide means of ensuring high standards in auditing practices.
- to improve management and organization of ASEANSAI by enhancing the internal and external communication strategy, streamline internal coordination, and maintain transparent management of ASEANSAI Finances.
- ❖ budget compilation from all committees for the 2018 2019 activities
