#### **EXECUTIVE SUMMARY**

In realizing its goal to accelerate economic growth, social progress and cultural development for a prosperous and peaceful community in the region, ASEAN recognises the need to engage the various stakeholders to build a more dynamic cooperation toward reaching the strategic objectives of ASEAN Vision 2025.

The first joint seminar of ASEAN, AIPA and ASEANSAI for Laying the Foundation for Future Cooperation in Promoting Accountability and Transparency in Southeast Asia was organized to establish a foundation for future collaboration among the three organizations. Designed along three sessions, the seminar has helped in developing and expressing a collective voice, finding a common ground and defining collaborative actions. This was achieved by bringing together midand high level officials of ASEAN, ASEANSAI and AIPA to identify common grounds, interests and commonalities for potential joint cooperation in the future.

H.E. Dr. (H.C.) Drs. H. Muhammad Jusuf Kalla, the Vice President of the Republic of Indonesia, officially opened the joint seminar, organized by these three organizations in a mutual effort. The session was followed by remarks of the dignitaries from the Embassy of the Federal Republic of Germany and all three organizations; ASEAN, ASEANSAI and AIPA.

The first session presented briefly the three organizations' profiles and scope of work, discussed commonalities and complementariness in thrusts, mandates, programs, and activities. The second session showcased good practices and discussed about the challenges in promoting transparency and accountability in the region. This session served as an inspiration for the participants to start thinking about potential collaborative actions for ASEAN, ASEANSAI and AIPA in the future.

The participants then divided into four focus groups to explore ideas for future collaboration and proposed activities. With the support of the digital event application Wissembly, contributions of the joint seminar's participants were efficiently and effectively captured, documented and managed, enabling an interactive exchange between speakers and audience. The final session aimed to pinpoint activities for joint efforts in promoting accountability and transparency in the future. This was based on the presentation of the focus group work's results. Proposals and suggestions were prioritized and discussed, to be subsequently taken forward by the technical teams of each organization after the seminar.

The participants proposed several actions. The following three were the top rated activities:

- 1. Joint research on regulation/training, best practices and learning exchange.
- 2. Capacity building activities that includes presentation and exchange on the preparation and use of audits, together with non-audit participants (e.g. Members of Parliament).
- 3. Creating a focus group involving ASEAN, ASEANSAI and AIPA and other stakeholders to discuss common issues that are cross cutting, e.g. the challenges and issues in implementing SDGs and cross-border issues.

These top collaborative actions proposed by the participants will serve as the milestone to be followed-up by ASEAN, ASEANSAI and AIPA in the future.

#### 1. Background

The Association of South East Asian Nations (ASEAN) was established in 1967 to enhance cooperation and promote peace and stability in the region. Despite the varying level of development among the member states, the association has started to develop its own identity and political mode of cooperation. Members have been working together successfully over the past years to improve the economic situation of their citizens, facilitate free movement of their people across borders and support each other when in need.

In realizing its goal to accelerate economic growth, social progress and cultural development for a prosperous and peaceful community in the region, ASEAN recognises the need to continue engaging various stakeholders to build a more dynamic cooperation toward reaching the strategic objectives of ASEAN Vision 2025. Several strategic measures have been identified which include fostering a more socially-responsible ASEAN by promoting good governance principles through greater transparency. It covers public and private sector, as well as other stakeholders, to improve transparency and synergies of government policies and business actions. It is also expected to help promote economic growth and good governance across Southeast Asia.

This effort requires intensive cooperation between governments and all stakeholders. At regional level, ASEAN parliamentarians established the ASEAN Inter-Parliamentary Assembly (AIPA) to build connections beyond the government level and to promote policies that benefit the people in ASEAN. This parliamentary dimension is important because it provides broader legitimacy to the ASEAN project by bringing decision-making and its deliberation beyond the work of ministers and civil servants. Parliament's annual approval of the national budget and its scrutiny of budget execution is one of the legislature's major functions. Despite the variation of powers between the Member States' parliaments in affecting the budget, the impact of parliamentary debates and scrutiny of annual budgets and parliaments' drive for fiscal transparency, Parliamentarians are key stakeholders in enhancing budget transparency, especially by exercising their mandate to oversee the national budget.

Meanwhile, the Supreme Audit Institutions (SAI) of each Member State play prominent roles to promote good governance and transparency in the public sector by ensuring the sound implementation of the approved national budget. The auditing of government and public-sector entities by SAIs is crucial in trust-building processes for the citizens as the SAIs provide check-and-balance for custodians of public resources. Once SAIs' audit results have been made public, citizens will be able to hold the custodians of public resources accountable. In this way, SAIs promote the efficiency, accountability, effectiveness and transparency of public administration. An

independent, effective and credible SAI is therefore an essential component in a democratic system where accountability, transparency and integrity are indispensable parts of a stable citizen-state relationships. This is how public-sector auditing becomes an important factor in making a difference to the lives of citizens. At regional level, SAIs of the ten Member States of ASEAN established the ASEANSAI as a platform for regional knowledge-sharing, networking and capacity development. The ASEANSAI, as an entity associated with ASEAN, is of the view that collaboration with AIPA is needed to promote principles of good governance, especially in the area of financial transparency and accountability.

In relation to that, the ASEAN Secretariat, ASEANSAI and AIPA organized this joint collaboration project to enhance regional cooperation in areas of good governance, transparency, accountability and inter-agency cooperation.

#### 2. Objectives

The joint seminar had three main objectives:

- 1. To establish a foundation for future inter-agency collaboration, through networking, exchange and interaction:
- 2. To identify common issues of interests and develop a basis for future cooperation while establishing closer ties among ASEAN, ASEANSAI and AIPA;
- 3. To help promoting good governance and improving accountability and transparency within Southeast Asia.

#### 3. Participants

This joint seminar was attended by 120 participants from the three organizations and related institutions. Among the participants were H.E. Dr. (H.C.) Drs. H. Muhammad Jusuf Kalla, the Vice President of the Republic of Indonesia; Prof. Dr. Moermahadi Soerja Djanegara, Chairman of SAI Indonesia; H.E Dr. Peter Schoof, Ambassador of the Federal Republic of Germany to Indonesia, ASEAN, and Timor Leste; H.E. Amb. Phasporn Sangasubana, Permanent Representative of the Kingdom of Thailand to ASEAN and Chair of the Committee of Permanent Representatives to ASEAN; Dr. AKP. Mochtan, Deputy Secretary General for Community and Corporate Affairs of ASEAN; Dr. Viengthong Siphandone, ASEANSAI Chairperson; Mr. Isra Sunthornvut, Secretary General of AIPA; Mr. Bahtiar Arif, Head of ASEANSAI Secretariat, Dr. Piyawat Sivarak, Representative of Chair of ACCSM; Dr. Fadli Zon, Chair of GOPAC. #### **OPENING SESSION**



**Prof. Dr. Moermahadi Soerja Djanegara**, Chairman of The Audit Board of the Republic of Indonesia, opened the joint seminar with his welcome remarks. He aknowledged that the joint seminar of ASEAN, ASEANSAI and AIPA served as an important milestone for future cooperation and sustainability in promoting accountability and transparency in Southeast Asia. The institutions represented in the seminar all have critical roles to reach the strategic objectives of the ASEAN Economic Community, the ASEAN Security Community and the ASEAN Socio-Cultural Community 2025, promoting a more responsive ASEAN.

Moreover, he highlighted that the advance of digital technology contributed for greater transparency which strengthened the good governance in ASEAN, encouraged the expansion of opportunities across the ASEAN region and to achieve the 2030 Sustainable Development Goals (SDGs).

The Audit Board of Indonesia (BPK) individually and as part of ASEANSAI recognized that accountability, transparency and integrity as well partnership with stakeholders are indispensable part of a stable democracy. Along with the ASEAN, ASEANSAI and AIPA, BPK's future activities will contribute to the achievement of both national and regional objectives. Therefore, the importance of emphasizing on the shared visions, common interests and goals were considered as an important link to bridge the differences to continue to support peace and inclusive societies in the region.

Following the welcome remarks, the keynote speech was delivered by the Vice President of the Republic of Indonesia, H.E. Dr.(H.C.) Drs. H. Muhammad Jusuf Kalla.



Vice President Jusuf Kalla addressed the importance of collaboration between countries in ASEAN. The long-standing existence of ASEAN has proven that the association was successful in nurturing collaboration in various sectors. Collaboration, particularly in the public auditing sector, was one of the important factors to provide a transparent system and improved accountability of the economy of each

state.

ASEAN comprised of a diverse community with people from different backgrounds, ethnic groups and languages. In this seminar, the participants would learn from other experiences which may lead to the establishment of good collaboration activities. This was aligned with the spirit of the ASEAN community which prioritizes cooperation and collaboration. The Vice President praised this joint effort in promoting good governance, transparency and accountability.

Following the keynote speech, the Vice President officially opened the seminar by hitting a gong accompanied by the diginitaries of the three organizations; ASEAN, ASEANSAI and AIPA.

#### SPECIAL REMARKS

# H.E. Dr. Peter Schoof, Ambassador of the Federal Republic of Germany to Indonesia, ASEAN and Timor Leste



H.E Dr. Peter Schoof highlighted the importance of having good governance, parliaments and audit for a better future of ASEAN. He underlined the importance of the government within the region and that governments, parliaments and audit institutions needed to establish a good network for the enhancement of regional cooperation and development. For this, it required the development of mutual knowledge, benchmarking, and identification of best practices, cooperation and collaborative spirit.

Furthermore, the German Government shared the country experience in the use of public funds. Through oversight, an integrated method of audit, surveillance, and parliamentary scrutiny, ensuring accountability and transparency, it has contributed for a better connection between the state and the citizens.

As the representative of the state, the German Ambassador was pleased to announce the support and promised continued support of Germany to ASEAN organizations by sharing the experience of Germany within the country and in the European region in the area of capacity building, environmental and climate protection, and sustainable economic development through regional integration.

# Dr. AKP. Mochtan, Deputy Secretary General for Community and Corporate Affairs of ASEAN



Dr. AKP. Mochtan began his remarks by emphasizing that accountability, transparency and governance are universal requirements which apply to all organizations, especially for public institutions as they are accountable to the public. He mentioned three important points to achieve good accountability, good transparency and good governance which were regulation, mindset and right institution. Regulation is critical for sustainability, ensuring transparency has taken place and as an umbrella for the law. Mindset is crucial as principle of a trustworthy individual involved.

In relation to promoting good governance and transparency, Dr. AKP. Mochtan talked about the revision of two key documents, namely ASEAN Staff Regulations and ASEAN Financial and Administration Procedures. The objective is for ASEAN Member States and agencies to build appropriate regional mechanism and instill a system that will safeguard, strengthen and enhance the capabilities in promoting transparency and accountability.

#### Dr. Viengthong Siphandone, ASEANSAI Chairperson



**Dr. Viengthong Siphandone** emphasized the prominent role of SAIs to promote efficiency, accountability, effectiveness and transparency of public administration. By having the support from Parliament and government as SAI's main stakeholders, SAIs may and can perform their role more efficiently and effectively.

Dr. Siphandone introduced the ASEANSAI and its activities since the establishment in 2011, focusing on capacity building in public sector auditing of its members states. With this, ASEANSAI contributes to the improvement of transparency and accountability

in the region.

One of strategic goals of ASEANSAI is to strengthen its active role within the ASEAN agenda and to improve the cooperation with regional organizations and international partners. Mrs. Siphandone expressed her confidence that this seminar would serve as a foundation for future inter-agency collaboration, through networking, exchange and interaction among the three associations. Thus, she affirmed the commitment to build future cooperation with ASEAN and AIPA, in promoting transparency and accountability in the Southeast Asian region.

#### Hon. Mr. Isra Sunthornvut, Secretary General of AIPA



Hon. Mr. Isra Sunthornvut noted that in this modern era, the indicator of the success of a country is not only through GDP, infrastructure, economic development or even the political development of a country, but also through the willingness of the government to be accountable and transparent to the people.

Mr. Sunthornvut acknowledged the gap of the idyllic concept of accountability and transparency and its implementation. Therefore, an alternative way to address the gap is to give the people the sense of responsibility and ownership in

overseeing the institutions. This way it is believed to improve the people's sense of ownership in promoting accountability in the use of public funds deriving from tax money. Furthermore, Mr. Sunthornvut encouraged the members of AIPA to promote transparency through actions, as this good practices will contribute to transform the concept into the practices to improve accountability and transparency in the ASEAN region.

- 2. Accommodated seminar participants from different levels to get to know each other, and to exchange and identify future areas of cooperation;
- 3. Future joint activities were identified between these three organizations in 2019 2020 to promote transparency and accountability for good governance in the ASEAN region.

#### **Session 1: Expressing A Collective Voice: Inter-agency Cooperation**

#### **Description:**

The session aimed to showcase the three organizations' profiles, discussed commonalities and complementariness in thrusts, mandates, programs, and activities.

#### **Summary of the Presentation**

Following the presentation of three videos of all organisations, the first open question addressed to the panel was:

How would you describe your organization's biggest contribution to strengthen transparency and accountability in the ASEAN region?

**ASEAN Secretariat** introduced the ASEAN Charter as the codes of conduct for both ASEAN Member States and ASEAN personnel. In addition, on a daily operation, the ASEAN Secretariat are guided by the ASEAN Secretariat's Staff Regulation (ASSR) and the ASEAN Financial Rules and Administrative Procedures (AFARP).

**ASEANSAI** underlined that one of the core organization's activities is to build capacity together of SAI member states both institutionally and regionally to promote transparency, accountability and good governance.

AIPA underlined that accountability and transparency were the two things that have been embedded in each member of the Parliaments, otherwise they would not be voted again by the constituents.

The question from Wisembly application asked about the readiness of these three organizations in facing the scrunity of their operations.

**ASEAN Secretariat** faces scrutiny regularly every day from ASEAN Member States, through organs like the Committee of Permanent Representatives (CPR) of ASEAN. There is also has the ASEAN sub-committee for budget, annual internal and external audit review, among others, to work with the ASEAN Secretariat.

**ASEANSAI** appointed an independent auditor from the members of ASEANSAI who audits the yearly financial statement. In the audit community, ASEANSAI has a model of leading by example. This means that the institution would have to be ready to be scrutinized, audited and watched by anyone who would like to see good governance of the institution.

**AIPA** stated that each organization would have its own internal auditor and its accountability would be open to public. AIPA is accountable for the members, and every year in its General Assembly, there would be a session where members could scrutinize the budget, the main source of which is taxpayer money.

The other question received from the application is how to promote or cultivate good governance mindset in the organization? There was also a related question concerning any support for the capacity building for Members of Parliament and the staff related to audit professions.

**ASEAN Secretariat** underlined the importance of having the ASSR and AFARP, in which the whistle-blower's identity to any wrongdoings is protected and concealed. .

**ASEANSAI** highlighted that the advantage of being a regional organization, the ASEANSAI shared similar characteristics and cultures that would be a great asset to build together their capacity, upholding ASEAN values in fostering good governance.

The facilitator then asked the speaker to explain the meaning of doing governance "the ASEAN Way" and about implications of ASEAN values, and why it would be different from any other ways elsewhere.

**ASEANSAI**; To implement good principles for ASEANSAI's work, one needs to look at the value of the people in ASEAN, such as the characteristics and the culture. This should also apply when issues are being raised, and it would thus be proper to solve any issues the 'ASEAN way'.

**AIPA** emphasized that ASEAN may not be operating similar to other entities such as the European Union, as it has different culture and characteristics of the people between these two regions. Each has its strength and uniqueness.

The next questions related were about overcoming one of the challenges among member SAIs which is confidentiality policy to prevent public exposure and corruption prevention among ASEAN countries.

**ASEAN Secretariat** highligheted the most critical part in a corruption case would not just be on the rule of transparency, but also on the law enforcement in dealing with the cases.

**ASEANSAI** noted that since there was no prior collaboration with the other two organizations, this would be a proper forum for good governance and for discussions on challenges that some members of ASEANSAI have. This included initiative to build a regulatory framework to communicate with the two other organizations for a better good governance in ASEAN.

**AIPA** shared similar view on preventive actions by having regulations and policies being put in place, as well as law enforcement in dealing with corruption cases.

The facilitator then asked about the opportunities for the three organizations to work together in the future in the area of promoting transparency, accountability and good governance.

**ASEAN Secretariat** recognized that there were many potential areas for collaboration between these three organizations. For example to engage common external auditors or applying common financial rules as these three organizations are based in Jakarta, making it easier to enable good coordination.

**ASEANSAI** welcomes future collaboration with the other two organizations. ASEANSAI would seek help or share concerns and experiences in conducting the audit mandates or good governance with the other organizations. Organizations should begin the collaboration work from small things, such as inviting the organization's representatives to meetings or assemblies, so that they could share their concerns on topics discussed.

The facilitator then raised a question on the potential outreach activities between these three organizations.

**ASEANSAI** stated the possibility to enhance collaboration among the organizations through maintaining close communication, having regular meetings with the other two organizations, and discussing on programs. The results would be shared to members, such as initiatives, proposal, ideas and so forth.

**AIPA** recognized the challenge to conduct outreach. The organization therefore should find a way to assert its importance to the lives of the people. As for the collaboration within the three organizations, initiative such as conducting the joint seminar is considered as a good step forward.

#### **Key Findings**

- Capacity building for SAIs, having code of conducts for member states and ASEAN personnel, a good track record of the parliament members could be highlighted as good practices implemented by the three organizations. As public organizations, the three entities recognized the importance of 'leading by example' to ensure accountability and transparency. Institutions have to be ready to be scrutinized, audited and watched by anyone who would like to see good governance of the institutions.
- Policies and regulations as well as law enforcement were considered effective ways to prevent and addressing the corruption.
- Potential collaboration between these three organizations should be started with small steps such as the joint seminar, inviting the organizations' representatives to meetings and activities, so that they could share their concerns on topics discussed.

#### Session 2: Transparency and Accountability: Finding a Common Ground

#### **Description:**

This session aimed to showcase good practices in the implementation of projects and initiatives to promote transparency and accountability in the region, to serve as an inspiration to participants in defining which initiatives ASEAN, ASEANSAI and AIPA could explore together in the future.

#### **Summary of the Presentation**



Jakarta, Dr. Piyawat Sivarak explained what a civil servant activally was and his/her critical role in promoting sustainable development in each country and good governance in the ASEAN community.

Mr. Sivarak's presentation explained the history of ACCSM, previously known as ASEAN Conference on Reform in Civil Service (ACRCS), founded in 1981. Dr. Sivarak stated the potential area of collaborations in the future, including education, labour, disaster management, or gender mainstreaming. He

encouraged organizations to expand partnership and strengthen tools in promoting sustainable civil service management in countries and in the region.

**Dr. Fadli Zon** highlighted the importance of transparency and accountability for good governance. Dr. Zon recognized the importance of stakeholders' participation to ensure the success of anti-corruption activities and offered more comprehensive solutions in addressing corruption issues. He acknowledged that cooperation between parliaments and SAIs is essential to improve accountability and inclusive participation for sustainable development as well as enhancing the public financial management.



Dr. Zon further mentioned that, since its establishment in 2002,

GOPAC has been actively involved in the global anti-corruption network and in fostering a strong anti-corruption partnership among parliamentarians. He mentioned activities including engagement with other stakeholders and a number of publications such as parliamentary handbook, that has been translated and adapted into country contexts.

The contributing factors that made GOPAC's work possible were among others: (1) Created practical guideline based on the need assessment of parliamentarians, (2) fostered strategic partnership with stakeholders and (3) continued to promote transparency and accountability within the institution.

GOPAC offered four recommendations to continue supporting the improvement of the transparency and accountability within the region. The first, to ensure that an effective democracy building process is taking place in the region. The second, to ensure that ASEAN ways of consensus built upon the commitment of transparency and accountability. The third, to encourage all ASEAN parliaments to strengthen public financial oversight mechanism by establishing Public Account Committees (PAC). The fourth, to mainstream and take the good practices forward within the AIPA framework.



**Mr. Michael Aguinaldo** emphasized the critical role of SAIs to promote public trust in governments through transparency and accountability. ASEANSAI Training Committee has conducted several capacity building programs based on the member states' need assessment.

ASEANSAI has trained a total of 130 auditors and established a pool of certified ISSAI facilitators and trainers. However, the success of these initiatives depend on the commitment of the ASEANSAI members to replicate and embed these programs into their own SAI. In this way, the ASEANSAI Training Committee could assess the impact of programs in

improving the capacity of SAIs to promote transparency and accountability in the country.

Mr. Aguinaldo concluded his remarks by highlighting four lessons learned from the implementation of Training Committee activities: (1) the importance of SAI leadership's support to the trained activities to establish their credibility among their peers in the SAI, (2) the involvement of the trained and certified ISSAI facilitators in SAI's capacity-building activities, (3) SAI to SAI support as in the case of the Trilateral Cooperation Project and the ASEANSAI-IDI Cooperative Financial Audit; and (4) the monitoring of the ISSAI's implementation through regular reporting or in knowledge sharing activities such as at the Senior Officials Meeting (SOM).

#### Q & A (from Wisembly app):

#### Is there any ASEAN civil servant competency standard?

**Dr. Piyawat Sivarak** responded that each country has different competency standards or frameworks. Therefore the platform to exchange information and share experiences on regional level is important, as it was done by the ACCSM.

#### Are the trainings conducted by the ASEANSAI applicable to the auditors of member states?

**Mr. Michael Aguinaldo** responded that the idea for Training of Trainer (ToT) is that the certified trainers or facilitators would be able to conduct trainings for ASEANSAI auditors as well as share the knowledge for the auditors in their own SAIs.

#### **Key Findings**

- 1. The critical role of civil servant to improve good governance in the region has been recognized by the ASEAN leaders by signing the ASEAN declaration on the role of the civil services at the Summit in Manila in April 2017.
- The importance of stakeholders' participation, as well as establishing collaboration among organization, such as joint activities between SAIs and Parliament to improve public financial mechanism and quality management of public financial management for accountability and sustainable development.
- Capacity building among ASEAN members could only success if the country is willing to adopt the programs into their country context, as well as utilizing the trained and certified auditors not only on country level, but also at regional level, as it is enabled through regional institutions like ASEANSAI.

#### **Session 2: Breakout Session/Group Discussion**

The first part of the session was followed by a one-hour breakout group session to discuss potential collaborative projects that ASEANSAI, ASEAN and AIPA could undertake together to promote transparency and accountability for good governance in the region. The participants were divided into four groups based on the color of their lanyard; red, yellow, green and blue.

Each group consisted of a facilitator, a note-taker and 10 - 14 participants from different organizations. The results of discussions of each group were presented in the third session after the presentation of the speakers.

#### **Session 3: Expressing A Collective Voice: Inter-agency Cooperation**

#### **Description:**

The session aimed to identify areas of collaboration for ASEAN, ASEANSAI and AIPA in promoting transparency and accountability in the region. These ideas, proposals, and suggestions were prioritized and discussed to be taken forward by the technical teams of each organization after the seminar.

#### **Summary of the Presentation**

**Dr. Piyawat Sivarak** shared ACCSM activities, as well as identified potential opportunities for collaboration among the three organizations. Furthermore, ACCSM expanded its network to work beyond ASEAN level to learn substantive matters relevant for ACCSM's work. ACCSM welcomes opportunities to share and exchange knowledge with other organizations in the area of competency, ethics, good governance, leadership, training and development and many more. He encouraged organizations to know and learn about each other's work to understand the needs and establish a common ground for future collaboration.



**Mr. Roslan Abu Bakar** recognized that the collaborative effort of the jointly organized seminar was a stepping stone for the future. He noted that in order to work together as a team, the three organizations could find common grounds and jointly build a strategic plan based on shared objectives and goals, such as the alignment with global goals such as SDGs.

Mr. Abu Bakar highlighted the importance of promoting SAI independence, as well as implementing SAI Peformance Management Framework (PMF)

and Key National Indicator (KNI) in order to strengthen ASEANSAI members. The implementation of PMF is a holistic and evidence-based framework to assess SAI performance in accordance with the ISSAIs. He also encouraged using KNI to measure the national performance and to evaluate impacts. The government can use the results for strategic planning, facilitating effective policy analysis, reporting as well as conducting program evaluation.

#### **Summary of Breakout Group Discussions**

Each group appointed a representative to present their top three proposals or suggestions on potential future collaborative actions for ASEAN, ASEANSAI and AIPA in promoting transparency and accountability for good governance in the ASEAN region.

#### Summary of proposed activities by Red Group

- 1. Encouraging capacity building in the form of joint research on regulation/training, best practices and learning exchange (**result:** 91% chose this proposal via Wisembly);
- 2. Encouraging organizational development by establishing a joint committee of SAIs MPs Government (**result:** 61% chose this proposal via Wisembly).
- 3. Encouraging awareness campaign by having an ASEAN day for good governance (result: 19% chose this proposal via Wisembly);

#### Most voted proposal:

Encouraging capacity building in the form of joint research on regulation/training, best practices and learning exchange (result: 91% chose this proposal via Wisembly);





#### **Summary of proposed activities by Green Group**

- 1. Organizing capacity building that includes a presentation on audit reports to non-audit based fellows (**result:** 78% chose this proposal via Wisembly);
- 2. Engagement of the highest decision makers among the three organizations (**result:** 59% chose this proposal via Wisembly).
- 3. Encouraging people involvement through bottom up-up approach. Thus, ASEANSAI to become ASEAN auditors because there are certified auditors to improve the organizations better (**result:** 40% chose this proposal via Wisembly);

#### Most voted proposal:

Organizing capacity building that includes a presentation on audit report to a non-audit based fellows

(result: 78% chose this proposal via wisembly);



#### Summary of proposed activities by Yellow Group

- Creating a focus group involving ASEAN, ASEANSAI and AIPA and other stakeholders to discuss common issues that are cross cutting, e.g. the challenges and issues in implementing SDGs and cross-border issues (result: 73% chose this proposal via Wisembly);
- 2. Promoting financial autonomy (including human resources) of SAI's and support for SAIs' independence by parliaments (**result:** 57% chose this proposal via Wisembly).
- 3. Creating a mechanism to allow ASEANSAI through external auditors to conduct audit on ASEAN entities that receive funds (annual contribution) from ASEAN public fund (result: 42% chose this proposal via Wisembly);

#### Most voted proposal:

Creating a focus group involving ASEAN, ASEANSAI and AIPA and other stakeholders to discuss common issues that are cross cutting, e.g. the challenges and issues in implementing SDGs and cross-border issues

(result: 73% chose this proposal via wisembly);





#### Summary of proposed activities by Blue Group

- Organizing baseline and joint research in that there is a relationship between government, SAI and parliament (understand SAI reports); this entails how the three organizations disclose financial operation and also a lobby for institutionalization of public accounts committees in parliaments (result: 77% chose this proposal via Wisembly).
- Organizing regular exchange formats in the form of workshops on strategic direction of cooperation or workshop in technical level or participation at ASEAN Summit 2019 (result: 62% chose this proposal via Wisembly);
- 3. Encouraging establishment in the form of a good governance committee that is represented by all three organizations (**result:** 37% chose this proposal via Wisembly); and

#### **Most voted proposal:**

Organizing regular exchange formats in the form of workshops on strategic direction of cooperation or workshop in technical level or participation at ASEAN Summit 2019 (result: 62% chose this proposal via wisembly);





#### Q & A (from the floor):

The facilitator summarized that there was a strong interest of commitment for collaborative actions among the three organizations starting from the first session, and there were concrete proposals from participants in discussing future works.

#### **Key Findings**

- Engagement of the highest decision makers among the three organizations is important.
- Potential areas of future collaboration among the three organizations are knowledge sharing, capacity building and joint activities based on the common interests and common goals, such as aligning the goals with global agendas such as SDGs.
- Establishment of linkages between SAIs and parliament will improve accountability in financial management as well as to lobby the creation of Public Accounts Committees in parliaments

#### **CLOSING SESSION**



H.E. Ambassador Phasporn Sangasubana, the Permanent Representative of the Kingdom of Thailand to ASEAN, in her capacity as Chair of Committee of Permanent Representatives, officially closed the one-day joint seminar by delivered her remarks. She highlighted the ASEAN commitment to the principles of democracy, rule of law and governance as stated in the ASEAN Charter.

ASEAN has established many partnerships and has engaged with various stakeholders both within and outside ASEAN. The joint collaboration activity between ASEAN, ASEANSAI and AIPA demonstrated a good practice in establishing cooperation within the ASEAN community which is people-centered and future-oriented for good governance. Furthermore, she highlighted that the voice of ASEAN entities should be heard in working together towards realization of the ASEAN Community Vision 2025.

# ASEAN - ASEANSAI - AIPA JOINT SEMINAR "Laying the Foundation for Future Cooperation in Promoting Accountability and Transparency in Southeast Asia"

**JAKARTA**, 26 **February 2019** – The Vice President of the Republic Indonesia Jusuf Kalla opened the first seminar promoting accountability and transparency in Southeast Asia in Jakarta this morning. The seminar was jointly organised by ASEAN Secretariat (ASEC), ASEAN Supreme Audit Institutions (ASEANSAI) and ASEAN Inter-Parliamentary Assembly (AIPA).

The three organisations recognise the need to build connections beyond the government level to promote accountability and transparency in ASEAN, benefitting the people. With the support of the German Government, through the "ASEC 2025", "Support to ASEANSAI" and "AIPA4ASEAN" projects, implemented by GIZ, the seminar brought together around 100 senior officials and representatives of the three organisations and other entities in ASEAN.

In his Special Remarks, the Deputy Secretary-General (DSG) of ASEAN for Community and Corporate Affairs, Dr AKP Mochtan, commended the timely convening of this important seminar, which he believes will contribute greatly to the advancement of the ASEAN Community as a whole. He highlighted that governments and public institutions usually use regulations to promote accountability and transparency. In this regard, he urged all ASEAN agencies to work together with the ASEAN Secretariat and to reinforce the importance of promoting good governance, which is a critical feature in the "ASEAN 2025 Vision: Forging Ahead Together".

Chairperson of ASEANSAI and President of the State Audit Organization of Lao PDR, Dr. Viengthong Siphandone, expressed her appreciation for the initiative to firstly co-organise this event. "Ten Supreme Audit Institutions (SAI) in ASEAN have established the regional association ASEANSAI, in 2011 in Bali, to promote capacity building in public sector auditing of its members. This way, ASEANSAI is contributing to the improvement of transparency and accountability in Southeast Asia," she said. Dr. Siphandone further explained that SAIs in ASEAN have contributed to the audit of financial statements of the ASEAN Secretariat every year. Supreme Audit Institution plays a prominent role to promote the efficiency, accountability, effectiveness and transparency of public administration. "With the support of Parliaments and governments, as SAI's main partners, SAIs will perform their role more efficiently and effectively in their respective countries," she highlighted.

Dr. Siphandone assured ASEANSAI's commitment to build future cooperation with ASEC and AIPA, to promote transparency and accountability in Southeast Asia.

AIPA Secretary-General Isra Sunthornvut appreciated the ASEANSAI for initiating a joint event on such important issue. He acknowledged the importance of having accountability for parliaments as well as having internal mechanism in each country to ensure the accountability to happen. He admitted, however, that applying accountability for regional organisations like ASEAN, ASEANSAI and AIPA, where there was little to no public interest, remained a challenge. Who and how to set the standard were other challenges, he added. Further, he stated that to make these regional organisations more people-oriented and people-centred, there has to be not only more people participation, but also a willingness from the organisations to be scrutinised and checked. people participation, but also a willingness from the organisations to be scrutinised and checked. "Otherwise, like the present-day ASEAN Community, we will be just another name that has no emotional connection to the people," he said.

During the seminar, participants identified good practices in their work to promote transparency and accountability of the public sector. They explored common interest and opportunities for future collaboration between ASEAN, ASEANSAI and AIPA to strengthen relationships and synergies of their works to contribute to Good Governance in ASEAN. This inaugural event of cooperation among the three ASEAN entities will develop concrete proposals for collaborative action in the future, to jointly work towards more transparency and accountability in the region. 

Good morning!

I would like to start by commending the timely convening of this important seminar on the promoting of accountability and transparency and strengthening of governance, all of which I trust will contribute greatly to the advancement of the ASEAN Community as a whole.

It is also indeed my great honor to give this Special Remarks and to share my perspective on the topic.

Governments and public institutions usually use regulations to achieve important outcomes. Evidence suggests that good regulation correlates highly with strong growth. This is possible because of the impact of good regulations in reducing transaction costs and opening up the markets for more competition. At the same time, it is critical that the regulations are sustained over time to ensure durable impacts, including the promotion of a well-functioning regulatory governance system that is effective, efficient, transparent and accessible. This governance system encompasses not only the development of regulatory policy instruments and tools, but also the right institutions through which regulations are made, developed and implemented.

What do I mean by the "right institutions"? Well, in ASEAN, the parliamentarians established AIPA to build connections beyond the government level

and to promote policies that benefit the people in ASEAN. This Parliamentary dimension is critical as it provides broader legitimacy to the ASEAN Community building. At the same time, each ASEAN Member State's supreme audit institutions (SAIs) play prominent roles to promote good governance and transparency in the public sector by ensuring the sound implementation of approved national budget, which is crucial in confidence-building processes for our citizens. The 10 national SAIs also established the ASEANSAI as a regional network-platform for knowledge-sharing.


This leads me to my next question. What then is the main challenge for ASEAN in terms of promoting better governance? Personally, I think one issue is the identification of an appropriate regional mechanism and measure for all member states and all ASEAN agencies to adopt and implement, in the name of "good governance". This is so given that varied stakeholders have diverse perspectives and different tolerance levels for corruption, bribery, accountability and transparency.

In that case, could ASEAN Secretariat, given our role and function as the nervecentre of the ASEAN Community building process, be a self-appointed "role-model in promoting "good governance", and be a learning example to our fellow ASEAN agencies? In the ASEAN Secretariat, we do have the twin manuals of the ASEAN Secretariat Staff Regulations (ASSR) and the ASEAN Financial and Administration Regulatory Procedures (AFARP). Both sets of rules do carry provisions catering to code-of-conduct, conflict of interests, and whistle-blowing. This is to generally encourage staff to adhere to the importance of accountability and responsibility.

#### Excellencies, Distinguished Guests, Ladies and gentlemen,

While I do not have an immediate answer to my questions, I certainly do look forward to a fruitful discussion at the Seminar, especially when it comes to identifying future opportunities for collaboration in the area of accountability, transparency and governance between the 3 agencies.

### Pointer

- 1. As a result of Focus Group Discussion from 2014 2015, ASEANSAI has developed Guidelines for Public Procurement which outlines general information about the public procurement audit so that all countries can adopt or use it as guidance. The guideline was drafted base on the study and research project to collaboratively address the issue to overcome the shortcomings and promote best practices in public procurement audit. To develop the Research Project on Audit of Procurement, each SAI was requested to prepare a country paper on the practices of public procurement audit to supplement the research to facilitate procurement auditing and to assist the SAIs in conducting an effective audit of public procurement.

  The guideline rolled out through series of workshop on audit of procurement in 2016 and 2017, the participants were required to submit action plan and its implementation in their working spaces.
- Currently, the Guidelines are now updated based on the workshop and the implementation of the action plan.

  2. ASEANSAI has develop the **Research Project on Revenue Audit** which aims to enhance the audit
- 2. ASEANSAI has develop the Research Project on Revenue Audit which aims to enhance the audit capability of ASEANSAI member countries in auditing revenue by exchanging and sharing of knowledge and current practices; and developing a general guideline on revenue audit. In parallel, a Guideline on Audit of Revenue was also developed to outlines a definition of public revenue and revenue audits. Whereas the details of revenue audit are documented and are in compliance with ISSAIs. All ASEAN countries can adopt or use it as guidance. The guideline is intended to help auditors understand the process of auditing public revenue. Therefore, auditors can audit public revenue as part of the financial and compliance audit or even evaluates the efficiency and effectiveness of Revenue Collection Agencies and to investigate fraud and corruption.
- 3. ASEANSAI Long Term Project on Implementing ISSAI (LTAPII), from 2015 2018, using the IDI certified ISSAI Facilitator to develop the organizational and audit capacity of ASEANSAI members in implementing the ISSAIs at the SAI and ASEANSAI levels. With the support from German Government and Workd Bank, ASEANSAI is now having 18 (eighteen) Graduates of LTAPII and manage to establish the Pool of ASEANSAI-ISSAI Facilitator whose eagerly and willingly support the dissemination of ISSAI in ASEAN region.
- 4. In addition, to ensure sustainability of the LTAPII graduates and to support the advocacy of the ISSAI Implementation, there is a need to encourage the implementation through the cooperation with IDI and Swedish National Audit Offie. The cooperation covers the support to implement cooperative financial audit project and continue in other field of audit; such as the Performance Audit and Compliance Audit by using the current perspective, like SDG Approaches. The programme started from 2018 until 2019.



Excellencies Chair of Supreme Audit Institutions,

Distinguished speakers,

Ladies and gentlemen,

A very pleasant afternoon to all of you.

- First of all, on behalf of the *Global Organization of Parliamentarians against Corruption* (GOPAC), allow me to extend my gratitude to this forum.
- I am pleased and honored to be here today. Thank you for having me on this important discussion, and giving me the opportunity to talk about GOPAC's works in fostering transparency and ensuring parliaments' accountability. I hope that our discussion today could be a momentum for Parliamentarians, Supreme Audit Institutions, civil society, and other stakeholders to gather, evaluate, and promote accountability and transparency through an anti-corruption global movement; as well as foster a regional common ground in Southeast Asia.

### Distinguished delegates,

- Let me begin by highlighting the importance of transparency and accountability as a precondition for the achievement of good governance. By being open and transparent, it ensures the delivery of public services and helps to sustain economic growth and development. As a part of ASEAN countries, we need to collaborate and promote accountability and transparency by doing active cooperation as well as providing assistance to each other.
- We have to acknowledge that implementing the good governance is not as easy as it seems. The countries face continues threats and challenges in order to implement an accountable and transparent government. Democracy is coming hand-in-hand with a transparent and accountable government. However, as we may know, most of the ASEAN countries are still in the phase of pseudo-democracy. Moreover, the power to influence the countries that are less democratic to improve their transparency and accountability is limited due to the ASEAN values of non-interference.

- In addition, the widespread corruption disrupt governance, destroy trust towards state institutions, and become a barrier in achieving sustainable development. Corruption purges the opportunities to build a better livelihood for the people as it steals away their rights to achieve equality, security, and prosperity.
- We realize that addressing corruption is hardly done alone. Participation from every stakeholder is essential to ensure the success of anti-corruption measures. Through cooperation and collaboration, the problem of corruption can be approached from various perspectives and produced more comprehensive solutions.
- Both the executive and the legislative bodies should be able to work together as a symbol of
  a balance of power. Moreover, cooperation between Parliament and Supreme Audit
  Institutions is essential to ensure accountable, inclusive, participatory and transparent
  sustainable development. Fostering strong financial management, through reliable reports
  and controls, could detect and prevent corruption as it promotes transparency and
  accountability in government programs and activities.

### Ladies and gentlemen,

- Since its inception in 2002, the Global Organization of Parliamentarians against Corruption (GOPAC) have been actively involved in the global anti-corruption network, while at the same time fostering a strong anti-corruption partnership among parliamentarians. Up until February 2019, we have 1397 members worldwide, as well as coordinated networks through 62 National Chapters and 5 Regional Chapters in Arab, Africa, Southeast Asia, Oceania, and Latin America. GOPAC is the only international network of parliamentarians dedicated to combat corruption, strengthen good government and uphold the rule of law.
- We developed several oversight handbooks such as: Financial Oversight, Improving Democratic Accountability Globally, and Guidelines to Strengthen Oversight through Parliamentarian Donor Collaboration. The handbooks intended to be a guide to how parliamentarians can increase the effectiveness of their oversight role and how to work together with partners to achieve the goals.
- Previously, we have also been partnering with international organizations, including encouraging and supporting the successful implementation of the 2030 Agenda for Sustainable Development Goals (SDGs). Together with the Islamic Development Bank (ISDB), UN Development Programme (UNDP), and Westminster Foundation for Democracy (WFD), GOPAC developed a Parliamentary Handbook as guidance for Parliamentarians to successfully implement the SDGs, especially by monitoring the effectiveness and accountability of any development assistance. As of now, the handbook has been localized and developed into national version. We are now actively promoting and encouraging all Parliamentarians to make use of this Handbook as a valuable resource in achieving SDGs targets.

### Distinguished participants,

• I would like to briefly elaborate the contributing factors which made those GOPAC works possible. The **first** one is by effectively identifying the needs of parliamentarians, so that our

tools could really provide practical guidance for them. For instance, while developing the SDGs Handbook in 2016, we organized a pilot workshop for parliamentarians from ASEAN countries to hear their feedback and accommodate their demands.

- Besides making sure that our tools could be easily adapted, we also ensure that they serve as opportunity to start discussions among key actors within and outside parliament. Hence, the **second** contributing factor is strategic partnership and coordinated efforts that we foster with related stakeholders; such as international institutions, academia, and civil society organizations. Our partners have contributed in formulating the handbooks, conducting workshops, providing consultation, as well as promoting the adoption and localization of our tools.
- The third contributing factor is parliaments' commitment in promoting accountability and transparency within their own institution. Although the engagement is varied regionally, parliamentarians are undertaking efforts to enhance their role in oversight function, such as by working on cross-party committees or working groups to push for their main objectives, and ensure the effective implementation of commitments adopted.

### Ladies and gentlemen,

- Regardless those progress that have been made in pushing forth the transparency and
  accountability, we have to admit that there are still challenges ahead, especially in our
  region. Here, I would like to outline several points on what more can be done to promote
  and deliver the regional transparency and accountability process, as well as strengthen
  parliamentary roles in achieving this agenda.
- **First,** ensuring an effective democracy-building process in the region, as a prerequisite of accountable and transparent governance. This democratic consolidation is very important because without democracy, there will be no participatory process, and even mere transparency will not translate into stronger accountability. In this regard, GOPAC is willing to intensify our support in democratizing states within the region, by encouraging ASEAN Parliaments to be more democratic. We call fellow ASEAN parliamentarians to strive for a much more representative, open, transparent, accessible, accountable, and effective legislative body in their respective countries.
- **Second**, ensuring that ASEAN ways of consensus are built upon the commitment of transparency and accountability. The democracy-building as a collective regional objective which I previously mentioned, implies that all ASEAN member-states should become democracies. That would require peer pressure on non-democratic member states; while at the same time this 'pressure' would arguably contradicts the existing ASEAN's principle of strict non-interference in the domestic affairs. However, we should remember that the ASEAN Charter itself clearly obliges member-states to "strengthen democracy, enhance good governance and the rule of law." Especially considering the real threat of transnational corruption and the pressing needs to maximize sustainable development, I call ASEAN to prioritize the principles of transparency and accountability in its internal decision-making process. This really is the common ground that we should aim for a strong regional community.

- Third, encouraging all ASEAN Parliaments to strengthen their public financial oversight mechanism, by establishing Public Accounts Committee (PAC) or equivalent audit working groups. This is very important, because parliament doesn't only have a role in approving budgets, but also in reviewing government spending and hold them accountable. The PAC should also establish liaison and work closely with the Supreme Audit Institution (SAI), as they have a common ground to oversight and audit government budget. The committee could review and make use of auditors' reports as the basis for their inquiries. GOPAC also calls for a productive relationship between PAC and SAI, where expert audit institutions could inform committees on the quality of financial management across the government, and identify areas for attention.
- **Fourth**, we should also push these agendas forward within the ASEAN Inter-Parliamentary Assembly (AIPA). The issues of democratic consolidation, assuring transparency, and improving parliament's accountability should be at the center of discussion among members of ASEAN Parliaments. Through their constitutional functions, parliamentarians should position themselves as the leader on implementing these principles in the region.

### Ladies and gentlemen,

- As a final message, I would like to reiterate that we do have great challenges which can only
  be solved by working together. Hence, we should promote transparency and accountability
  in the ASEAN region by taking great opportunities to collaborate and work towards the same
  goals with the same level of ambition.
- GOPAC is open to collaborate, and look forward to fostering strategic partnership in improving institutional capacity and ensuring the effectiveness of legislative reform.
- Let us work together to help break the culture of corruption, and help ensure that Parliament and other public institutions in the region are accountable and trustworthy for the benefit of all people.



















# STRATEGY ONE: Promoting ASEANSAI Independence











